Wednesday, 12th January: Penitentiary Centre

8:30 – 10:00 The partner delegations are divided into 2 groups as follows:

- The first group is divided into sub-groups to observe teaching situations led by the ULE teaching team (Mrs SICAUD, Mrs BOUCHUT, Mrs DEFOUR, Mr MEGEMONT & Mr GUILLIN). This was followed by discussions with the prisoners who had taken these courses.
- In the meantime, Mr JEAN presented to the second group the organisation of education in prisons in France at national and regional level.
- 10:00-11:30 The groups are reversed so that each participant can benefit from each workshop (pedagogical observation and presentation of the French educational system applied to the prison environment).
- 11:30 12:15 **Visit of PC's Women's quarter:** Discussions with detainees.

14:00 - 17:00 Three new rotating workshops are organised:

- Mrs. SICAUD, Local Education leader, presents her missions for the local organisation of schooling for detainees (including the computer tool of the Prison Administration dedicated to the management of detainees: GENESIS);
- Mrs. BOUCHUT, ULE teacher, presents a specific teaching method aimed at facilitating the involvement of learners: Global simulation.
- Mr. JEAN presents the digital platform developed by the UPR to enable the preparation of the "Diplôme d'Accès aux Etudes Universitaires" (DAEU), a platform that contains a set of educational resources, self-correcting exercises as well as audio and video documents that can be accessed without an Internet connection. He mentioned the experiment currently being conducted at the Villefranche/Saône prison, where 10 prisoners have a laptop equipped with this platform in their cells.

1) Exchanges between partners, particularly with regard to the degree of response obtained during the M1 in relation to their expectations:

• Penitenciarul GHERLA - Raluca COC :

« Very intense days.

Very happy to have been able to share so much (resources, visits, functioning of the prison, school centre). Very interesting to see teachers in a classroom situation, very intellectually stimulating.

Great interest in the IT tools presented (prison tool GENESIS and school activity management tool CURSUS. It was noted that it seems to be easier to draw up schooling lists (in GHERLA, these documents have to be countersigned by several successive prison officers).

Conducting a course was particularly appreciated, as were the various exchanges with the detainees».

• CPIP - Marius BABAN :

« All three of us were new to this project, so we didn't really know what to expect and we found it a great experience. The objectives were clearly defined.

The teams from St-Etienne and Lyon are very united and work well together.

The tools presented, especially the digital ones, are very interesting.

The classrooms are well equipped and the detainees seem to be well treated, which is essential for teaching to take place in good conditions.

We very much appreciated the fact that the teachers are not stressed and the relationship they have with the staff and the detainees ».

• EPAPU-Nelson MANDELA - Melca RUIZ-DOMINGUEZ :

« In addition to what has already been said, and to which we fully subscribe, our team is aware that we have learned a lot from this transnational meeting about the functioning of prison education in France. We also gained a better understanding of how the Romanian system works.

Mr ARNAU-REBOREDO thanked Ms GARCIA PROL for having had this experience ».

- 3) Exchanges between the partners as to their expectations for the next transnational meeting (M2) which will take place on 8, 9 and 10 March 2022 in A LAMA: Mrs BOUCHUT, ULE of St-ETIENNE, expresses in particular the wish to meet the management of the establishment, to visit the prison and to conduct a course with detainees and then to have time to exchange with them.

Marta GARCIA PROL, EPAPU, believes that this will be possible and invites each partner team to specify by email its specific expectations regarding the organisation of M2.

Finally, he thanked Mr REYMOND, Head of the prison, and through him all the teams at the prison for the welcome they kindly gave to the partner delegations, as well as GIPAL for its indispensable and very efficient support in the financial management of this meeting.
